LOSS CONTROL SCHOLARSHIP APPLICATION

OUR MISSION IS TO SAVE LIVES THROUGH SAFETY TRAINING AND EDUCATION.

Eligibility

- **Applicants must be a child of an employee** of an electric cooperative, municipal electric utility or contractor participating in TEC Loss Control services, such as organizational safety meetings, Loss Control schools or the Loss Control Conference in the last 12 months.
- **Applicants must graduate from high school or earn a GED in the same year** the scholarship is awarded.
- **Scholarship recipients must meet entrance requirements and enroll in a college or trade school** during the first fall semester after the scholarship is awarded. Scholarship funds will be paid directly to the appropriate institution.
- **Application deadline:** January 17, 2023 at 5:00 pm.

All applications must include

- **Two letters of recommendation** from teachers, counselors, coaches, community leaders, clergy, or electric cooperative directors or managers. One must be from a current teacher. Applicant's parents are not eligible to write letters of recommendation.
- **A 300-word, typewritten essay** on one of the following topics:
 - The Importance of Safety and Training for Linemen
 - The Importance of Safety at My Electric Cooperative
 - How Does the Cooperative Business Model Benefit the Members of My Cooperative?
 - How Was My Cooperative Formed?
- **A description of volunteer involvement** in school, church or community organizations
- **A description of supervised work activities**, including job title, responsibilities and names of employers
- **A statement of goals for the future**
- **A high school transcript or proof of GED score**

Application Deadline is January 17, 2023 at 5:00 pm.
