I. **POSITION SUMMARY:** Direct the overall engineering operations of the Cooperative; Interface with consumers or their representatives to ensure design requirements, electrical codes, safety codes and prudent engineering practices are followed in the construction of projects; Initiate and/or interface with the Cooperative's consultants, regulatory agencies and power supply entities to meet governing body regulations, expansion of the Cooperative electrical system, and maintain a secure supply of electric power.

II. REPORTING RELATIONSHIPS:

Reports to: General Manager

Supervises: Engineering Technician; Crew Foreman – Engineering; Work Order Clerk; Engineering Field Coordinator; Patrolman; Equipment Technician; Community Relations Specialist.

III. MAJOR RESPONSIBILITIES:

- a.) Direct the overall engineering operations of the Cooperative
 - i.) Supervise the technical and operating staff of the engineering department
 - ii.) Aid the staking, construction and maintenance departments as needed
 - iii.) Prepare a Work Plan and a Capital Budget to support the Work Plan
 - iv.) Solicitation of RFP's for capital projects
 - v.) Responsible for the analysis of the Cooperative's transmission and distribution system and the design and construction of complex electrical power systems
 - vi.) Maintain a knowledge base of products, procedures, industry initiatives and governmental regulations
 - vii.) Compile and evaluate design and test data
 - viii.) Prepare technical specifications and analyze technical data to determine appropriate limits and variables for product, process or materials specifications
 - ix.) Prepare and study technical drawings, specifications of electrical systems and topographical maps to ensure that installation and operations conform to standards and customer requirements
 - x.) Operate computer assisted engineering and design software and equipment to perform engineering tasks
 - xi.) Confer with engineers, customers and others to discuss existing or potential engineering projects and products
